





### How to Stay Abreast of DARPA Solicitations - SAM

  - 3. Follow DARPA





#### What Award Instruments Does DARPA Utilize?



- 1. Procurement Contracts
- 2. Other Transactions for Prototypes
- 3. Other Transactions for Research
- 4. Grants and Cooperative Agreements





# Award Instrument Types – 1. Procurement Contracts



- <u>Acquisition instruments</u> acquire goods and services for the direct benefit of the Government
- Governed by:
  - Federal Acquisition Regulation (FAR)
  - Defense FAR Supplement (DFARS)
- DARPA utilizes Cost Reimbursement contracts
- Requires an adequate accounting system (i.e., reviewed by DCAA and found to have no material deficiencies)
- Most applicable to traditional defense contractors



## Award Instrument Types – 2. Other Transactions for Prototypes



- Acquisition instruments provide goods/services to the Government
- Requires the delivery of a prototype
  - "prototype" can take many forms, not necessarily just hardware
- Commercial-like instruments
- FAR/DFARS do not apply
- Either fixed price or expenditure-based
- Note: expenditure-based is not identical to cost reimbursable
- Milestone-driven
- Most applicable to non-traditional defense contractors

Some DARPA programs exclusively utilize OT for Prototypes





## Award Instrument Types – 3. Other Transactions for Research



- Non-acquisition instruments support and stimulate an activity for the general public good
- Commercial-like instruments
- FAR/DFARS do not apply
- Default expectation is 50/50 Government/Performer cost share to the maximum extent practicable
- Either fixed price or expenditure-based
- Note: expenditure-based is not identical to cost reimbursement
- Most applicable to non-traditional defense contractors

Often utilized for dual purpose research






## Award Instrument Types – 4. Grants and Cooperative Agreements



- Non-acquisition instruments support and stimulate an activity for the general public good
- Governed by:
  - 2 CFR 200
  - Department of Defense Grant and Agreement Regulations (DoDGARS)
- FAR/DFARS do not apply
- Most applicable to universities


## Not applicable to many DARPA programs

- Controlled Unclassified Information (CUI)
- Prototypes








- DARPA's term for post-selection clarifications/information gathering
  - Labor rate support
  - Vendor quotes
  - Subcontractor documentation
  - Etc.


★ Taking a step back, however, including this information in the proposal will preempt this process and very likely will reduce the award timeline.







- DARPA's objective is to minimize, or ideally eliminate, negotiations
  - In all of our solicitations, we are including model award documents with expected terms/conditions
  - In many of our solicitations we are preestablishing a reasonable fee/profit range
- For Other Transaction awards, you have the opportunity to convey the <u>value</u> of your proposal, which may expedite/eliminate negotiations

#### Opportunity to see your game-changing solution to fruition

- Milestones
- Reporting
- Technical Interchange Meetings
- Regular interaction with DARPA PM
- Contract modifications:
  - Incremental funding
    - Always unilateral
  - Option exercises
    - Usually unilateral
  - No-cost Period of Performance (POP) extensions (details on next slide)
    - Always bilateral
  - Task adds
    - Always bilateral





### No-Cost Period of Performance Extensions (NCEs)



- A performer requests an NCE when it needs more time to complete the effort <u>at no</u> <u>additional cost to the Government</u>
- Requests must be made to the CO (with a cc to the DARPA PM) no later than 30 days prior to the end of the current period of performance
- NCE requests must include the following information:
  - Program Name/Contract Number
  - > Current Period of Performance End Date
  - ➤ Requested New Period of Performance End Date
  - > Total Funding Currently Obligated
  - > Total Expenditures to Date
  - > Remaining Available Funding
  - > Reason(s) for the Extension Request
  - Program Impact





## MTO Officewide BAA - Accelerated Award Option



- DARPA places much emphasis on "seedling" awards via its officewide (OW)
  BAAs, as these awards often inform new DARPA programs
- MTO OW BAA Accelerated Seedling Award Option
  - Proposer must agree to a preset list of stipulations (see BAA Attachment F)
  - In exchange for this agreement, DARPA will commit to making the award within 30 days from the proposer's receipt of the selection notification letter
